With reference to your application dated 23/11/2025 and subsequent school inspection, I hereby convey the **grant of Recognition** to **Shree Ram Vidhyalaya Secondary School, Govinda Campus, Ahmedabad Highway, Palanpur – 385001** for **Secondary Section (Classes IX & X)**, for a period of **3 years**, from the academic year **2025–26 to 2027–28**, in compliance with **Section 18 of the Right of Children to Free and Compulsory Education Act, 2009** and **Rule 5 of the Gujarat RTE Rules, 2012**.

The above recognition is subject to the following conditions:

1. The temporary recognition is valid from **2025–26 to 2027–28** and must be renewed every **3 years**.
2. The grant of recognition is for **Classes IX & X (Secondary Section)**.
3. The school shall abide by the **RTE Act, 2009** and the applicable **State Education Act / Rules**.
4. For Class I admissions, (if applicable), the school shall admit **25%** children from **Weaker Sections & Disadvantaged Groups** as per RTE Act.



5. A **separate bank account** shall be maintained for reimbursement purposes where applicable.
6. The school shall **not collect any capitation fee** or subject children/parents to screening.
7. The school shall not deny admission to any child on grounds of:
 - a. Lack of age proof (after extended period).
 - b. Religion, caste, race, place of birth, or any such criterion.
8. The school shall ensure:
 - a. No child is expelled or held back during elementary schooling.
 - b. No child faces physical punishment or mental harassment.
 - c. No Board examination for children until completion of elementary education.
 - d. Inclusion of CwSN as per **RPWD Act, 2016 & Gujarat Notif. Rule 3..**
 - e. Teachers possess minimum qualifications as per **NCTE norms & Gujarat Education Act.**
 - f. Teachers follow duties under **RTE Act Sec 24.**
9. The school shall follow the **curriculum prescribed by the appropriate authority.**
10. The school shall maintain standards and norms under **Gujarat Education Regulations 1974**
11. No unrecognized classes shall run within or outside the school premises.
12. Building plans must be approved under current rules/G.O. Construction shall not be carried out during school hours and safety is the management's responsibility.
13. The school shall be run by the registered public trust **Matrushri Ratanben Ramchandhbhai Govinda Foundation Trust** under relevant State Act.
14. The school shall **not be run for profit.**
15. Accounts must be audited and certified by a Chartered Accountant.
16. The school shall furnish reports and comply with instructions issued by the Government/Competent Authority.
17. **Gujarati and Hindi** shall be taught as language subjects in Standards I to X as per applicable rules.
18. The school shall abide by the **State Education Act / Rules.**
19. The recognition is subject to removal if deficiencies remain unrectified.
20. The management shall rectify all deficiencies pointed out by authorities.

21. The management shall apply for renewal **three months before the expiry** of this order.
22. The management shall follow all Government/Department directions regarding safety and administration.
23. Recognition shall be withdrawn for any violation of the Act, Rules, or conditions.
24. Management is fully responsible for any legal matters. The school cannot seek affiliation to another Board without **NOC from the Competent State Authority**.
